Don Drennan is Named Mr. Camp Timberwolf

At its January meeting, the Camp Timberwolf Board of Directors honored Don Drennan for his 12 years of service by passing a resolution and presenting a plaque naming him **Mr. Camp Timberwolf**. Don has served four years as Vice President and eight years as President.

The plaque—a Special Commendation—thanked Don for his “outstanding Leadership, Vision, Inspiration, and Hard Work in preserving and improving our camp for generations to come.” It also stated, “It is with honor and gratitude that we award you the title of **Mr. Camp Timberwolf**.”

Although Don has just completed a four-year term as president, he has agreed to serve as vice president for 2006.

Camp Expenses and Fees

In 2005, the camp expenses were at the rate of \$31.55 per camper per week. This was greater than the camping fee of \$30 per camper per week.

A graph on page 3 shows the camp expenses calculated on a camper-week basis. As reported by Don Drennan in his President Don's Comments, insurance was our largest overall expense—at almost 35 percent of the total.

President Don's Comments

I have had the privilege of serving as President of Camp Timberwolf for eight of the past twelve years that we have managed the Camp. Talented, motivated, and dedicated men and women have surrounded me. Their contributions, though unheralded, have given you the Camp that you enjoy today.

BSA Troop 212 of Moraga, CA has been camping here for over 25 years. In 1994, facing closure of Camp Timberwolf, a group of Scout dads and men from Moraga Valley Presbyterian Church took over Camp Timberwolf. Many of these men continue today.

Mission

Our goal then and now is reflected in our Mission Statement: *To preserve Camp Timberwolf as a wilderness camp for use by Boy Scout Troop 212, church youth groups, families, and other scout and youth groups that are focused on a quality outdoor camping experience.*

During these past years, we have faced many challenges. When we began operating Camp Timberwolf, the infrastructure needed a long overdue upgrade. Over the years we have replaced the electrical system, septic system, built bathroom additions to all three cabins, renovated the kitchen storage area, rebuilt the shower room, replaced the dining hall foundation, added a new larger dining hall deck, installed new refrigerators and a beautiful new stove with hood, built a raft, and enlarged our camp boundaries.

The final phase of this rebuilding program is scheduled for completion this spring. We plan to upgrade the wiring in the dining hall with new circuits and new overhead lighting. We will also finish floor work in the shower building which will permit easier cleaning and do away with the rubber mats. We hope to build a boat storage rack, too.

Camp Finances

We are faced with unprecedented increases in costs. Basic insurance costs have tripled from \$2,000 per year to over \$6,000 per year for 2006. Based on a 12-week summer rental season this means that \$500 per week of your fees go toward camp insurance. PG& E, propane, water testing, garbage collection, property tax, US Forest Service lease fees, and basic maintenance costs are all much higher. These increases necessitated the recent hike in rental fees.

Under Scrutiny

We have faced several incidents at Camp Timberwolf in the past few years that have brought unwanted attention to us. We have had two fires caused by campers—either of which could have been disastrous but for the prompt action to contain them. We have had complaints from our Forest Ranger about fires outside of the campfire area. One group left a huge mess on the beach after holding an illegal campfire there.

We have suffered several thefts from Camp including tools, two new outboard engines, and a kayak, and damage to two sailboats rendering them useless. Everyone must be alert to these

issues and ways to uplift the camp and our image and reputation.

Guests

We are guests of the US Forest Service at Camp Timberwolf. True, we lease the land but our lease can be terminated if we violate the terms of the lease or other Forest Service regulations. We need to behave as the guests that were are.

I have been blessed to work with many of you. I am enthusiastic about the future of Camp Timberwolf under able leadership Rudi Metzner and his team of officers and directors.

I thank you for the opportunity that I have had and the help that I have received.

Fall Work Party

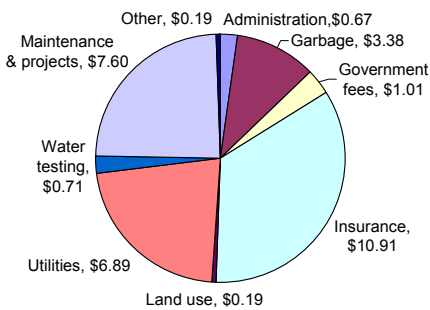
A group of volunteers went up in late September to put Camp Timberwolf "to bed" for the winter.
